The Appellee contends that this action is barred by the statute of limitations for filing a claim against a municipality. I agree that the filing of a notice of claim against a municipality within six months of

the event causing the injury will toll any statute of limitations for filing a claim. The Appellee states that the date of his injury was in the summer of 1987. He had until November 15, 1988, to file a claim. He filed his claim on December 1, 1988, within the six month statutory period. Since his injury occurred in 1987, the filing of his notice of claim in 1988 was timely. Therefore, I believe that the lower court did not err in finding the Appellee's complaint to be timely. In an attempt to avoid the statute of limitations, the

Appellee cites *Head v. H.C.A.D., Inc.*, *supra*, as authority for the proposition that he should be allowed to pursue a claim against the Appellant for damages resulting from the 1973 accident. In *Head*, a decision of this Court on a certified question from the Supreme Court of West Virginia,[1] this Court held that the statutory six month time limit for a suit against a municipality applies to all causes of action, not just those arising from a prior lawsuit. The Appellee argues that West Virginia Code § 55-2-12 is unconstitutional

in light of the Head decision. I do not agree. We are not dealing with a cause of action which arose prior to the adoption of the West Virginia Constitution. A cause of action accrues on the date of injury. The statute of limitations is a procedural device, and, so long as it is not unconstitutional, a cause of action will not accrue until the period has run. See, e.g., Metz v. Atlantic Assur. Co., 139 W.Va. 674
